

Minutes of the 26th LGBR Sub-Committee meeting

1. 26th LGBR Sub-Committee meeting was held on 08.07.2022 through Video Conference.
2. Member Secretary, NRPC extended a warm welcome to all participants in the meeting. He informed that this meeting is being conducted to review the planned maintenance schedule of generating units from 1st September 2022 to 15th October 2022.
3. NRPC representative informed that 25th LGBR Sub-Committee meeting was held on 04.02.2022 and minutes of the meeting were issued on 04.02.2022. Based on discussions held in the 25th LGBR meeting, the anticipated power supply scenario of Delhi for Summer 2022 was later discussed in a separate meeting held on 15.02.2022, in which Delhi SLDC was required to follow-up with all DISCOMs to firm up their availability figures and submit the same to NRPC/NRLDC latest by 28th Feb 22. Delhi SLDC vide mail dated 03.03.2022 submitted the availability break up of summer 2022 (LTOA + STOA + proposed STOA) to NRPC Sectt.
4. It was mentioned that based on the deliberation held in the Ministry of Power on 03.06.2022 during review meeting on coal supply issues, the Ministry desired that planned outage from 1st Sep'22 to 15th Oct'22 should be minimum possible so as to have adequate capacity available to meet expected demand.
5. The request of APCPL submitted vide email dt. 07.07.2022 for overhaul of below mentioned IGSTPP units was discussed in the meeting and the agreed revised schedule is as below:

6. Rajasthan vide mail dated 06.07.2022 submitted the revised annual maintenance schedule of RRVUNL power stations for FY2022-23 as on 06.07.2022, which was discussed in the 26th LGBR sub-committee meeting. Based on the discussions held in the meeting, annual outage schedule for following units were tentatively revised:

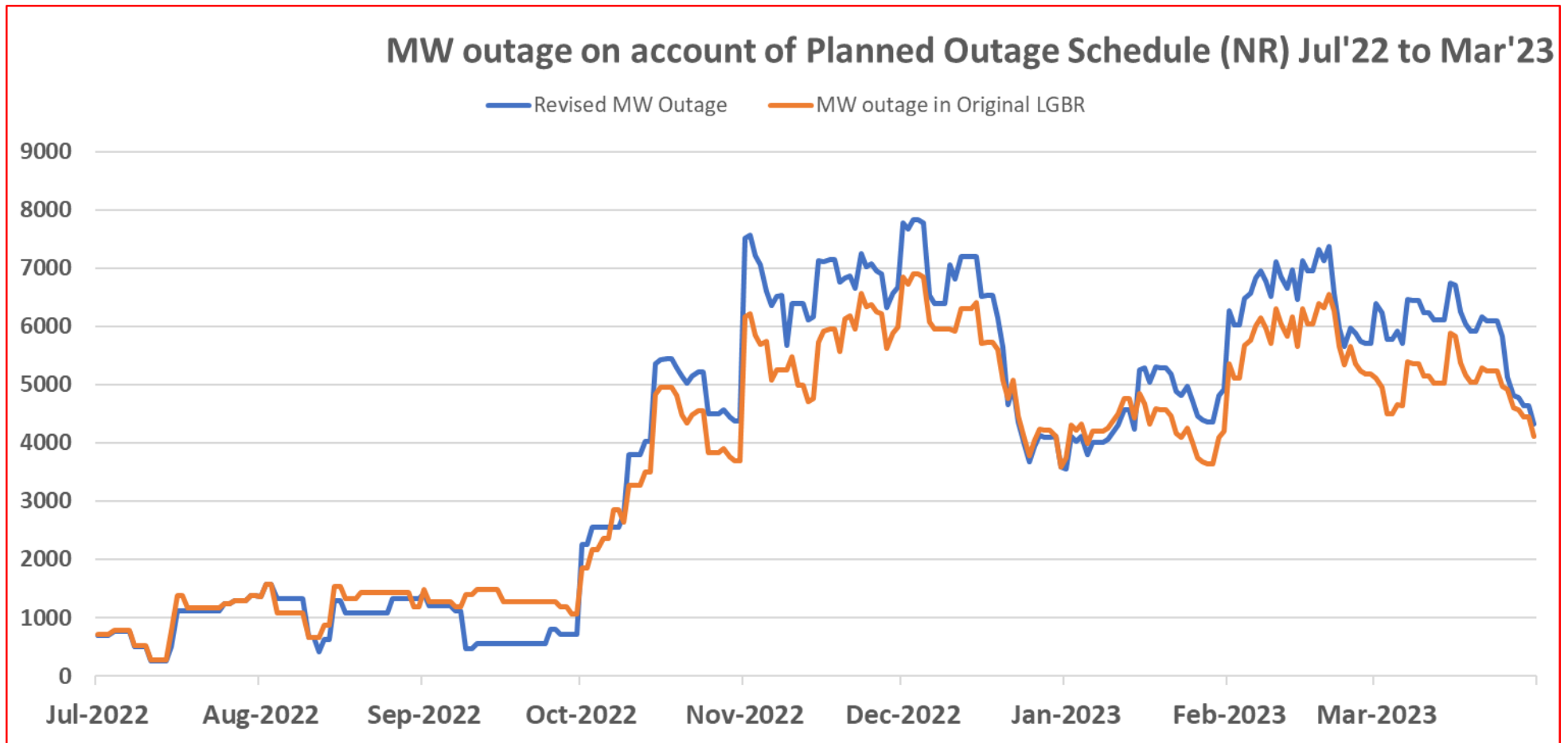
7. The request of Adani Power for preponement of planned overhaul of Unit 2 of KAWAI TPS was discussed in the meeting. On account of high demand, the sub-committee declined the request of Adani Power and asked to take planned overhaul of Unit 2 of KAWAI TPS from 10th Oct'22 to 08th Nov'22 for 30 days.
8. In the meeting, NTPC also proposed revised maintenance schedule of below mentioned NTPC stations, which was also discussed in the meeting and the subsequent revised schedule is as below:

9. It was decided that till 15.10.2022, the planned shutdowns of generating units falling in next month shall again be reviewed in monthly OCC and depending upon real time grid conditions in consultation with POSOCO, the final decision of allowing shutdown for next month shall be taken. Slight change of dates, if required, may be considered.
10. SE(O), NRPC also briefed the sub-committee that OPM Division of Central Electricity Authority has requested respective RPC's to pursue inputs on certain points (details enclosed in the letter of OPM Division, attached in agenda) with the generating utilities of their region.
11. In this regard, NRPC Sectt. vide mail dated 05.07.2022 has requested all the NR generating units that cited information as desired by CEA shall be submitted in prescribed format by 31st July.
12. The MW outage trend on account of planned outages is enclosed as Annexure-I and the copy of the presentation covering meeting agenda is attached as Annexure-II.

- It was decided that Delhi SLDC shall submit the breakup of these availability figures to NRPC Sect. for further analysis and after analysis of these figures, a meeting may be held in second week of February among representatives of NRPC, NRLDC, Delhi SLDC and Delhi DISCOMs.

- Delhi SLDC vide mail dated 03.03.2022 submitted to NRPC Sectt. the availability break up of summer 2022 (LTOA+STOA+Proposed STOA).

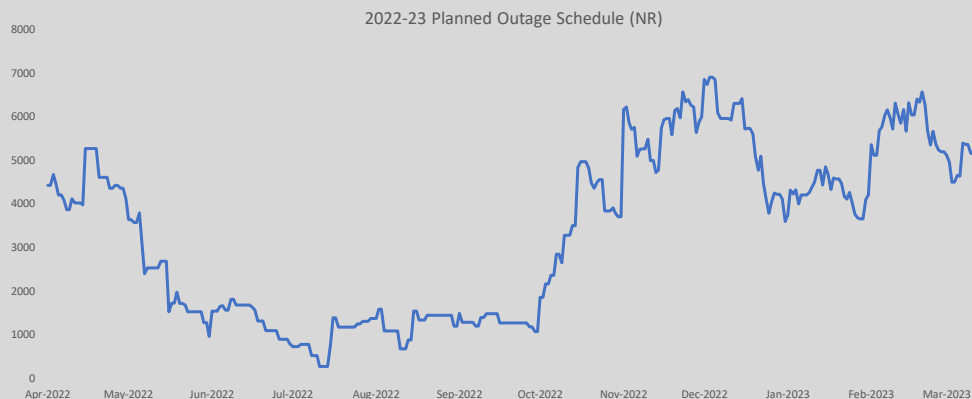
- Meeting taken by Secretary (Power) on 03.06.2022
- As discussed in the meeting, planned outage from 1st Sep'22 to 15th Oct'22 should be minimum possible so as to have adequate capacity available to meet expected demand.

Review of planned outages from 1st Sep'22 to 15th Oct'22.

- POSOCO vide letter dtd. 08.06.2022 has communicated the need to review the planned outages proposed from 1st Sep'22 to 15th Oct'22 to ensure bare minimum planned outage of thermal units in aforesaid months so that all India electricity demand in the upcoming months could be met without any constraint.
- The matter was deliberated in 196th OCC meeting held on 22.06.2022, and forum was of view that a LGBR sub-committee meeting may be conducted, wherein the planned outages proposed from 1st Sep'22 to 15th Oct'22 may be reviewed.
